§125 Plan for Elected Officials**

WHEREAS, York Township has, and continues to provide full health and dental coverage for their elected officials as provided for in Ohio Revised Code §505.60, and;  
 WHEREAS, York Township Board of Trustees has agreed to offer cash in lieu of a benefits plan as set forth in Ohio Revised Code §505.603 through a cafeteria plan that meets the requirements of §125 of the “Internal Revenue Code of 1986”, and;  
 WHEREAS, York Township Board of Trustees will reimburse those who are not eligible, or who pay for other insurance up to \$100 per month per family unit and \$50 per month per single unit, providing it is for the same type of coverage, and;  
 WHEREAS, such cash payment in lieu of benefits will only be paid pursuant to this plan if the elected official signs a statement affirming that the elected official is covered under another health insurance or health care policy, contract or plan, and;  
 THEREFORE BE IT RESOLVED that the York Township Board of Trustees hereby adopts a cafeteria plan that meets the requirements of §125 of the Internal Revenue Code and authorizes any qualifying elected official a cash payment in lieu of a benefits plan as set forth in the Ohio Revised Code §505.603, and  
 FURTHER, BE IT RESOLVED that the qualifying elected official shall sign a statement affirming coverage under another health insurance or health care policy, contract or plan to receive either \$100 per month per family unit or \$50 per month per single unit, providing it is for the same type of coverage.

I regret to inform you that I am unable to attend the monthly Trustee meeting in December. In my absence I am submitting this monthly report.

**Run Response:**

This month's runs are shown in the monthly run report attached. We responded to two structure fires in Litchfield. I have also attached the Year to Date report.

**Training:**

Monday night trainings included: Firefighter Vital Signs/Rehab Operations, Mutual Aid Box Alarm System (MABAS), and Communications. I attended a Fire Instructor update course at CCC. We sent one Firefighter to a live burn training to assess its value. He reported a very worthwhile educational experience and highly recommended it. I will be utilizing this in the future for others to gain some live fire experience. We have an Ice Rescue course set up for January 29<sup>th</sup> through Dive Rescue International.

**Activities:**

This past month our Department delivered Santa at the Historical Society. The annual Holiday Parties for our Township and Fire Department were a great success, thanks to all for their coordination and organization of the events, and to all who came out to gather outside the work environment.

**Administration:**

I have received a response on our applications for the 2010 AFG FEMA Grants. Congressman Sherrod Brown's Office contacted us to congratulate us on receiving a FEMA AFG Grant. This was for new turnout gear, a washer, and a dryer. Total award was approximately \$64,000. At this time I have not heard an official award from FEMA. I will be applying for an Equipment Grant and a Training Grant from the State of Ohio Fire Marshall's Office. I will also be applying for a small government loan, as we spoke, through the State Fire Marshall's Office. I will be requesting \$100,000 to be used toward replacement of Engine 51-1. This would be a 10 year loan at 0%. There is only \$300,000 available statewide.

**Personnel:**

I have spoken with Mike Stricker recently and was notified he has moved to Brooklyn Hts and would no longer be able to function with the department. I asked him to send me a resignation letter and make arrangements to return department equipment.

I have spoken with Dick Hill regarding his status with the department. He would like to be covered by the department to be a member of the County Fire Investigation Unit. I let him know it should not be a problem, except that I have an inquiry in to the State Fire Marshall's Office to clarify if you must have a Firefighter certificate or not to function as a Fire Investigator in the State. Dick's Firefighter certifications expired in 2009. Once I have clarification back from the State, I will establish a job description for Fire Investigator for the department.

I have a new employee recommendation, Michelle Seymore, for your discussion and approval. She has completed the EMT-Basic course and has had a background check and medical evaluation. She also has current NIMS training and CPR. She was unable to attend this evening due to visiting her son in the Coast Guard in North Carolina. We could perform her swearing in at a later date.

I have attached an Officer Recommendation Letter and Reimbursement Schedule for 2011 for your approval.

Again, I apologize for not being in attendance and I thank you for the opportunity to work with, and lead, this department today and into the future. Especially for all the support the Township Trustee Board gives to our Fire Department. Please contact me with any questions or concerns regarding these matters.
