The February 7, 2011 meeting of the York Township Trustees was called to order at 6:00 p.m., by Chairman Rick Monroe. Present were Trustees Colene Conley and Bill Pavlick; from Medina County Engineer's Office: Hal Gerspacher, Civil Engineer and Assistant County Engineer Andy Conrad. Everyone was present to review the Spellman/Indoe pavement and drainage as well as the upcoming sidewalk replacements for the Community Development Block Grant (CDBG) that York Township was awarded.

Hal Gerspacher explained the possibilities regarding the re-milling of Spellman and Indoe Streets and areas for proper drainage, along with adding a possible sidewalk from the Historical Parking lot to Columbia Rd. Current estimates are approximately \$131,000. This would also include a cement stabilized base along with 18' wide pavement. This would increase the width of Spellman and Indoe Streets. Motorpaver and Chip Seal were discussed. Andy Conrad mentioned that there was a possibility of Issue 1 monies that may be available, but certain criteria existed that would need to be looked into to see if this project would meet the qualifications. He also mentioned that there were 0% interest loans that were worth possibly looking into, along with Small Government Grants. Trustee Conley asked if Andy Conrad felt the project on Spellman and Indoe would qualify for the Small Government Grant. Trustee Monroe stated he felt it would also be beneficial. Andy Conrad and Hal Gerspacher stated they will explore the ideas of the Small Government Grant and if the work does not qualify for a grant, will calculate a motorpaver with a chip seal overlay for the project area.

Andy Conrad stated that the Township was only awarded approximately \$48,000 from the CDBG grant. This grant, alone, would not be sufficient to complete Rt. 18 area and the Columbia Rd. sidewalks. The Engineers believe there may be some drainage issues along the North side of Rt. 18 and Indoe Streets that may need to be factored into the costs of the sidewalks. The trustees felt that they would at least like to do the Rt. 18 portion of the sidewalks if the estimate was within a reasonable cost, along with the grant allocation. Andy Conrad asked who would be working with him on the sidewalks, Trustee Monroe stated Trustee Conley had worked on the grant and would be his contact. Andy Conrad stated he would call Trustee Conley when the weather breaks.

Discussion took place concerning ODOT's plan to install a larger culvert under Columbia Rd., directly across from Spellman Street, with the possibility of a ditch enclosure to the North of the Spellman intersection. The Township will need to contact Kimberly from the ODOT Medina garage to secure a copy of the plans. The Engineers stated that possibly the waterline under Columbia Rd. will also need to be lowered for the State of Ohio's culvert replacement.

Andy Conrad also stated to the three Trustees that Fred Boreman is currently working on the paving bid package for Wolff Rd., from Columbia Rd., west to Station Rd.. The package should be ready to be bid by the end of March, 2011.
