Chairman Bill Pavlick called the special meeting to order at 6:00 p.m. He led the pledge of allegiance. Present: Colene Conley, Richard Monroe, William Pavlick, Dorothy Crouch and Bev Fry.

Bev reviewed the township's valuation, millage and forecast of all funds. Due to the rearrangement of the inside millage, since the General Fund and Road & Bridge Funds operate on the inside millage, we are need of additional revenue through a levy.

There was much discussion and concern on what type of levy will pass and when to put it on the ballot. There was the concern of leaving the inside millage in the General Fund until a levy passes since there are not enough things to cut to maintain a positive ending balance in the future. There was also the concern of having no money to do road work with.

There was discussion on the health insurance offered to the elected officials. With a clarification from the County Prosecutor's Office, it can't be taken away from elected officials' mid-term because of O.R.C. 505.60. That raised the question of can it be "voluntarily" given up, which needs to be asked of the Co. Prosecutor's Office. Bev will contact Mr. Karris for clarification on whether an elected official can voluntarily give up the insurance.

The discussion continued on with maybe putting on a road levy in November. The deadline to the Board of Elections for November is August 7<sup>th</sup>. Then, what size of a levy – 1.7 or 1.8?

Bill asked when we would ask to leave the entire inside millage in the General Fund. Bev said it would be done with the tax budget this summer.
