- Training topics over past month vehicle familiarization, vehicle checks, pumping and drafting (including a training at Ron Pfaff's pond on Norwalk
- Participation in local 4th of July Parades and at Lodi Sweet Corn Festival Parade
- They started awarding FEMA Assistance to Firefighters Grants on July 13th, still in the running

In two weeks Jason will be attending a three day class "School Based Risk Threat and Vulnerability Training" sponsored by Sheriff and paid for by Westfield Insurance to form a team for each school district in the county to make/update preplanning for such events. Anthony Strazo and Ben from Valley City will also go in case someone from the township is unavailable. We hope to have discussion involving John Girard, the school resource officer and have our action plan ready by October 1, 2018

- Equipment reports: we can expect many more years of service out of the truck 57-2. Improvements including a new booster line, and real high visibility markings and better LED lighting were made. This is in addition to maintenance repairs made earlier in the year

RESOLUTION 18-07-06 – Hire Granger Paving

Moved by Pavlick, second by Zieja to hire Granger Paving to fix Bachtell & Branch culvert for a cost of \$2,450.00. Want to wait several months to submit to allow settling. Roll Pavlick, yes; Zieja, yes; Monroe, yes.

- Got a call at 7170 Spieth Rd for a culvert repair. It was a double culvert, which makes it a bridge, therefore this is the county responsibility and they sent out a crew to repair.
- Trash Picker – Solid Waste/Single Hauler. Bill called Dennis Horvath and Paul Shaffer to get the ball rolling and get a price set to see if we would want to participate in a merged plan. There will be an educational meeting on August 15, 2018 from 7-9 at the engineer's office to determine if we want to go with a single hauler.
- Got Grass – Still waiting for Dan to submit a contract for 2019 as his current three year contract ends at the end of the year. It was noted he does not need to weed wack every week in the cemetery as the summer season progresses.
- Lester Road Paving – Dick Hill had a question – “Why are we weed-wacking every week?” Pavlick gave background that when Kasich took 20% of everyone's budget, we could only afford to do roadside mowing 2x per year. After talking with Fred Boreman, who we have hired as a consultant, and has saved us a lot of money on paving, it was agreed that weekly weed wacking of the berm during this paving project will make the road paving better by increasing the integrity of the berm. Hill disagreed, stating the county and the state do not do this, so it seems wasteful. He also stated the Lester road-paving project did not seem necessary at this time, and should have been put off for a couple years. Discussion ensued. Monroe and Pavlick, stating the berm saves the road, and the project was necessary due to the erosion of the curves, and the quality of the materials used should last for 10 – 12 years as opposed to county standard materials which only last 5 – 7 years. They also requested that any questions about Township decisions should be directed to the Trustees, and not to the employee who is executing the work.

Todd Zieja

- Stated Sherriff's report for May and June showed approximately 260 calls each month. This was not an unusual amount of activity for the month.
- National Night Out- an evening designed to allow law enforcement to go out into the community. We are hosting the Sherriff's Night Out venue at the park on August 7, 2018 from 7-9pm, since this year's

fair schedule allows for local participation. He talked with Chief Barrett and we will have a couple people available for questions. The Sherriff's department is providing Hot Dogs, Magic show, Face Painting, Finger Printing, DNA Dots, and many other activities.

- Cemetery Plot Discount – Zieja would like to open a discussion about providing a discounted price for employees of the township. It is a nice benefit if you have lived and worked in the township. Items to consider for discussion: Percentage discount, \$ discount, Related to years worked or minimum year service for eligibility. Rick will research how other townships price plots.

Rick Monroe

- Lester Road Paving – Close to finishing
- Sight distances on 57. A lot of vegetation is growing and impairing sight. Called the state. They are very busy and will get to it. Rick will monitor.
- Park signs came in
- Park benches are sealed
- Speith Rd was bermed between Marks and Abbeyville, but the berm is being torn up. Wondered if it might be pick-up trucks speeding, farm equipment or people driving off edge.
- Asplundh Tree is still parking in our lot, it has been 2 months and will be a while yet. In exchange, they have taken down 6-8 trees in the cemetery. There is more work to do, and they have stated they will do additional work in the park too.
- Park dumpster – called Kurtis Perkins several times. Received a monthly rate of \$53.13 and an on-call rate of \$32.70 for winter collection. Since it is August already, we will probably wait until next year to make a decision. We can also check when we get a single hauler if this will be provided.
- OPWC Funding – we have not received any funding in this area since the Spellman and Indoe project. We are exploring the idea of resurfacing Erhart Rd, which needs it. This would likely be a successful bid because it is a shared road between 2 townships. Requesting county road speck 402- leveling course, which will last 10-12 years. Chip seal, slag stone, berming and stripping. Will need a coordinator for the project.
- NEO Steamers will be giving free rides on Saturday, July 28, 2018 from 4-8pm. Bob Miller stated this was an enjoyable experience for his granddaughters, and this was a hidden treasure in the Medina Park System.
