#### Paula Wodzisz

- Why do you want the position; what can you offer and what are the challenges you think you will face?

#### Ken Barco

- What are your thoughts on Township Zoning generally, and specifically our township?
  - o *James*: Would not want to see any big developments come into the township. Believes there should be minimum acreage for future developments.
  - o *Todd:* Zoning is crucial to our expansion, must have the regulations and thoughts to prepare for any expansion. Having the Zoning Boards and Zoning Code are essential to fit our needs as well as the communities; agrees that he doesn't want to see housing units or major housing developments, wants the minimum acreage to continue.

**David Hull** stated he likes to see the turnout there is tonight and as a member of the Zoning Commission, which is currently working on the Comprehensive plan, he would love to see people attend their meetings. They meet the first Thursday of every month at 7pm.

- What are your feelings towards sewers coming into the township?
  - o Todd: If it's something we need, can afford and will solve a problem then all for it. The round-about at Spieth was a terrible design by ODOT and caused many problems for nearby homes.
